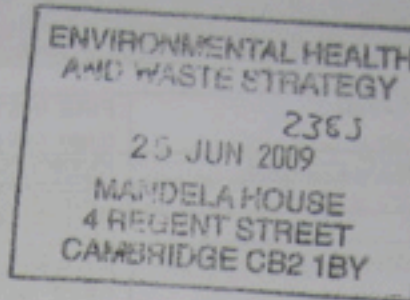

We have, however, enclosed a copy of our policy on the provision of portable fire-fighting equipment within stores. This document clearly lays down the system adopted in all stores as to the placement of fire fighting equipment and safety notices. It also addresses all the requirements laid down in article 3 of the Transitional Provisions regulations.


We can also confirm that notices advertising the application will be displayed at the premises from 26th June 2009 to 23rd July 2009 and in a local newspaper within the required time scale.

	<p>The belief is based in part upon existing statistical analysis of evidence of incidents of criminal and anti-social behaviour, nuisance and disorder in and around the vicinity of the subject premise, which are located within an area identified by the authority as one where the cumulative impact of the grant of additional premises licences would be such that there would be an increase in such undesirable activities regardless of the manner in which the premises are operated.</p> <p>Evidence adduced in support of such representations may comprise the first hand knowledge of officers involved, as well as police records from the Command and control logs, police crime files and/or CCTV footage.</p>

If the licensing authority considers that relevant representations are made the licensing section may consider arranging a mediation meeting between the relevant parties (if all agree) to try and reach a settlement. If this informal process is unsuccessful a hearing before the Licensing [Sub-] Committee will follow, unless the interested parties withdraw their representations.

All representations in their entirety will be disclosed to the applicant for the premises licence.
